







Figure 1. Epoxy glass hard tissue, board thickness 1.5 mm,  $R_{thJA} \, {\leq} \, 110 \; K/W$ 



 $Figure\ 4.\ Average\ Forward\ Current\ vs.\ Ambient\ Temperature$ 




Figure 2. Thermal Resistance vs. Lead Length




Figure 5. Reverse Current vs. Junction Temperature




Figure 3. Average Forward Current vs. Ambient Temperature





Figure 6. Forward Current vs. Forward Voltage

#### **Ozone Depleting Substances Policy Statement**

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

**TEMIC** can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
